O R D E R

As per the reference cited I, permission was accorded by the Government for starting certain Aided and Unaided Arts and Science and Training Colleges within the territorial jurisdiction of Mahatma Gandhi University during the academic year 1994-'95. Provisional affiliation was granted to these colleges vide reference cited II subject to certain conditions laid down in the University Order cited fourth. These orders were challenged before the Hon'ble High Court and the Hon'ble High Court of Kerala stayed the operation of the University Order granting affiliation.

An appeal has been filed against this stay order before the Hon'ble Supreme Court of India. The Hon'ble Supreme Court of India in its judgement directed the three Universities in the State that the colleges in respect of which any of the three Universities has followed the procedure relating to affiliation as required by the statutory provisions noted above would be granted affiliation for the academic year 1995-'96 or for such other period, permitted by law.

Considering the whole matter in detail, sanction has been accorded by the Vice Chancellor subject to ratification by the Syndicate to the following colleges being granted provisional affiliation with the courses and number of seats noted against each during the academic year 1995-'96.

- 1) to start classes in the above colleges from June 1, 1995 subject to the conditions that they will fulfil all the conditions specified (except the construction of buildings and shifting the college to the new premises) in the University Order cited fourth.
- 2) For the construction of buildings and shifting of the college to the new premises, a period of six months is granted.
- 3) The Sahodaran Ayyappan Memorial Training College, Poothotta and Himayathul Muslimeen Trust, Randarkara, where classes commenced before the stay order by the Hon'ble High Court of Kerala are deemed to have come into existence in the academic year 1994-'95 in pursuance of the Supreme Court directions and they are allowed to present students for the ensuing B.Ed Annual Examinations.
