**ORDER**

On the basis of the reports submitted by the Inspection Commissions concerned, the sub Committee of the Syndicate on Affiliation and Approval, vide paper read (2) above, resolved to recommend to grant extension of provisional affiliation for the under mentioned Unaided Self financing Arts & Science colleges up to the academic year 2021-'22. Sanction has been accorded by the Vice-Chancellor, exercising powers under section 3.10(17) of the Mahatma Gandhi University Act 1985, for the same.

4. The collection of annual administration fee from the students under any circumstances is not permitted.
5. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.

provisional affiliation in accordance with the Government NOC. The Vice Chancellor approved the recommendations exercising powers under section 3.10(17) of the Mahathma Gandhi University Act 1985 and orders issued accordingly, vide papers read (11) and (12) above. The recommendations of the University to start the proposed Programmes were forwarded for the NOC of the Government of Kerala. vide paper ( 13) above.

Government of Kerala, vide paper (14) above, accorded administrative sanction to the above mentioned self financing colleges for starting new Programmes /Batches/Permanent Seat Increase during the Academic Year 2021-22.

In the light of the Government NOC, the University directed the Self-financing college managements vide papers read (15) and (16) above, to furnish a copy of signed agreement with the Government along with an affidavit of submission of above to the Department of Higher Education and submit an agreement with prescribed clauses, signed, to the University.

Sanction has therefore been accorded by the Vice Chancellor under section 3.10(17) of Mahatma Gandhi University Act 1985 to the following colleges for New Programmes/ Additional Batches/Permanent Seat Increase during the academic year 2021-'22 and to duly include these courses in the CAP 2021.

Sanction has also been accorded by the Vice Chancellor under section 3.10(17) of Mahatma Gandhi University Act 1985,

(1) to reject the request of the Principal, St.Thomas College for advanced Studies, Thompikandam, Edamury, Ranni, vide paper read (17) above, for granting more time to fulfil the above said directions, since the CAP admission procedure ends on 25.11.2021, and

(2) to start the newly sanctioned programme, M.Sc Artificial Intelligence in the coming academic year 2022-23, as per the request of the Principal, Mar Athanasios College for Advanced Studieds, Thiruvalla, vide paper read (18) above.

The Principal, Mar Athanasios College for Advanced Studieds, Thiruvalla is directed to take immediate action to suspend the newly sanctioned programme, M.Sc Artificial Intelligence for the academic year 2021-22 as per The Mahatma Gandhi University Statute 1997, Chapter 23, Statute 15(1).

It is also directed to charge the tuition fee for all UG programmes as per the GO.(MS) No.209/2013/H.Edn, Dated. 29.05.2013, Serial No.3 (18,750 Rs/ Semester) and for all PG programmes as per the serial No.6 (22,500 Rs/ Semester) of the same order. The College management shall request to the Government to fix the tuition fee for all the UG/PG programmes for which tuition fee is not yet fixed.

The affiliation granted shall be subject to the compliance of Act/Statutes/bye-Laws/rules and regulations of the University and UGC on instructional and infrastructural facilities, faculty, qualifications etc. by the colleges.

Provisional affiliation is granted subject to the following conditions:

1. The provisional affiliation is granted initially for a period of one Academic Year only.
2. The affiliation of programmes is subject to the approval of regulatory authority if any.
3. The Management shall prepare and present the students in accordance with the laws of the University for the examination and as per the approved scheme and syllabus of the University in the subjects concerned.
4. As per G O read (9) above, the Educational Agency shall set apart 50% of the seats of the course for being filled up by the Government or such Authority determined by Government on the basis of merit and reservation principles followed by the Government and the remaining 50% filled by the Educational Agency on the basis of merit.

4. The details of tuition fee and other fees are as detailed below:

- b) Students insurance premium @ Rs.25/- per student per year.
- c) Students welfare fund @ Rs. 30/- per student per year.
- d) University Union fee @ Rs. 55/- per student per year.
- e) Sports affiliation fee @ Rs. 210/- per student per year to be utilised in the ratio, @ 50:50 by the University and the college.
- f) The collection of annual administration fee from the students under any circumstances is not permitted.
- g) Student's affiliation fee @ Rs. 550 & 750 /- for UG & PG courses collected on one time basis from all students shall be remitted to the university within 15 days after closing of the admission.
5. The rate of Tuition Fee is as per Government/ University orders issued from time to time.
6. The Educational Agency shall furnish an undertaking in a stamp paper worth Rs. 100/- to the University to carry out faithfully, the provisions of the Act, Statute, Ordinance and Regulations and the directions issued by the University from time to time in so far as they are related to the college, and to appoint and fix the service conditions of the teaching & non teaching staff in the college for conducting the courses as followed by the Government on conducting similar courses. The Principal of the college shall endorse the undertaking.
7. The Educational Agency will agree to collect only such fees as determined by the Government/ University from time to time from the students admitted to the course
8. The college shall submit the list of students admitted and remit the fees due to University within 15 days after closing admission.
9. Non-compliance with any of the above conditions would lead to the withdrawal of the affiliation without any prior notice.
