Whereas both the parties shall jointly organize academic programmes of which the expenses shall be shared equally.

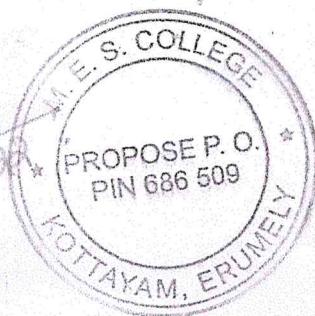
This MOU serves as a legal document for both parties to share and exchange knowledge


Now, therefore St.Dominic's College Kanjirappally and MES College Erumely hereby enter into an agreement to be mutually adhered to by both the parties whose terms and conditions are below.

1. The Joint academic events shall be conducted in either of the two colleges or elsewhere as the situation may demand.
2. In case the event is conducted in either of the two colleges, the infrastructural facilities necessary for the conduct of the same shall be provided by the host party free of cost.
3. The organizational expenses including such expenses like that of the TA/DA of the Resource person and publicity shall be shared equally by both the parties.
4. The expenses on food shall be borne by both the parties on their own.
5. In case the event is conducted elsewhere, all the expenses shall be shared proportionally.
6. This MoU shall be valid for three years from the date of signing of this agreement. After the said period it may be renewed for further period by mutual consent of both parties.
7. This MoU is executed in English. The original will be hold by the first party and a copy of the same shall be kept with the second party. However the first party is liable to provide the original document on request of the second party as and when required for official purposes.

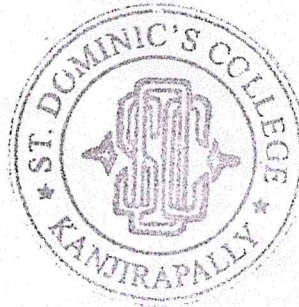




